These outdoor hydronic heaters, therefore, constitute "qualified energy property" under the Tax Relief, Unemployment Insurance Reauthorization, and Job Creation Act of 2010, and are eligible for tax credits under the American Taxpayer Relief Act of 2012, which extended the 2010/2011 tax credit for 2012/2013, the Tax Increase Prevention Act of 2014 extended the credit through December 31, 2014, and 25C Tax Credit for Biomass Stoves which extends the credit through December 31, 2020.
